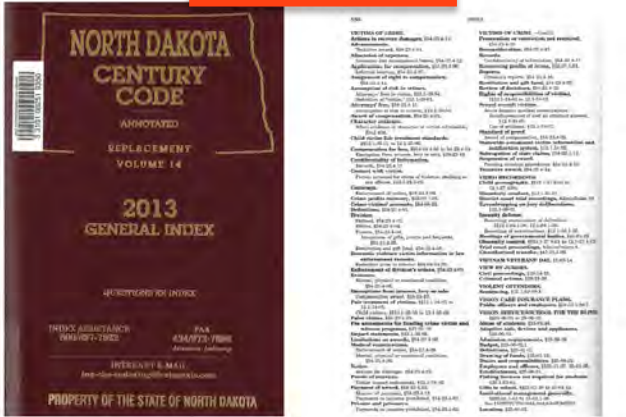

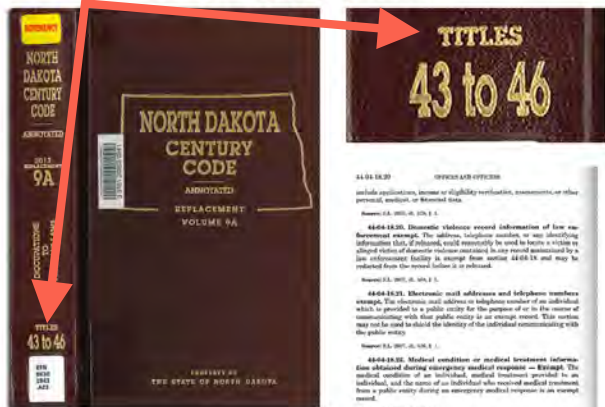
There is a search feature but no index in the online NDCC other than a listing of the 65 titles.
