# ADVANCED LEGAL RESEARCH Fall 2021

#### **COURSE DESCRIPTION**

In this course, students will learn to be efficient, thorough, and cost-effective legal researchers. Students will learn how to find and use the core sources of legal information, both primary and secondary, including: statutes, cases, administrative regulations and decisions, other executive branch materials, legislative history, constitutions, court rules, and secondary sources. Students will also learn how to research certain non-legal materials relevant to the law. Coverage will focus primarily on federal legal research and state legal research (with a special emphasis on North Dakota and Minnesota). Both paid and free legal research resources will be examined.

#### **COURSE GOALS**

- Understand how to find and use the core sources of legal information, both primary and secondary
- Be able to conduct legal research efficiently, accurately, and cost-effectively in both familiar and unfamiliar areas of law
- Understand an attorney's professional and ethical obligations in conducting legal research

## **REQUIRED READINGS & VIDEOS**

This course does not have a required textbook. Instead, the instructors will select and provide readings and/or videos for each topic. These materials will be posted to Blackboard each Wednesday afternoon, a week before the date on which the topic will be covered.

## **TECHNOLOGY REQUIREMENTS**

This course will focus primarily on online legal research. Students will work in groups to conduct legal research during class and should bring their laptops to every class.

#### **GRADING**

Because learning is an ongoing process, students should not be afraid to make mistakes. Students are expected to be professional at all times, but not perfect. Thus, if you show up (and show up on time), make a good faith effort on all assignments, ask for help when you need it, and treat one another with respect, you will do well in this course. Outcomes matter, so this course is graded, but demonstrated effort will account for a greater portion of your grade than in courses that rely more heavily on memorizing and applying unchanging concepts.

#### LATE ASSIGNMENT POLICY

Assignments that are turned in late will incur the following penalties:

Assignments more than 48 hours late will not be accepted, and zero points will be awarded.

#### ATTENDANCE POLICY

Students are expected to come to class on time and to be prepared. Excluding the first day of class, students may not miss more than one class during the semester. Except in extraordinary circumstances, missing more than this will result in a half-letter drop in your grade for every day over one that you miss.

To facilitate the ability of students to stay on track even if they must miss classes, we will create a Zoom link for students to attend remotely. Note that, at this time, we are not able to accommodate group work remotely, so students attending in that manner will not be able to engage in all aspects of the class session. Because of this, Zoom attendance should be used sparingly, such as when you have an illness that makes it unadvisable to be on campus; if a student attends too many classes via Zoom, we reserve the right to remove this option. If you

have any special circumstances that you'd like us to consider related to this policy, please do not hesitate to reach out to us to discuss.

Additionally, being on time and staying for the whole class is mandatory. Excluding the first day of class, students may be late to class or leave early once without penalty. After that, each lateness or early departure is counted as half an absence, and the penalties for excessive absences discussed in the previous paragraph will apply.

If, due to weather-related or other issues, travel to campus is impossible or inadvisable for a critical mass of the class, we will hold class via Zoom.

#### **COVID-RELATED PROCEDURES**

All members of the University community have a role in creating and maintaining a COVID-19 resilient campus.
