### COMMENCEMENT SPEAKER PROFESSOR PAUL E. TRAYNOR

Professor Paul E. Traynor was born in Devils Lake and is a fifth generation North Dakotan. One of nine members of his family, across four generations, to have graduated from the University of North Dakota School of Law, he is a proud UND legacy.

He began his formal education at the University of North Dakota, graduating with a Bachelor of Arts degree with a double major in History and Classical

Languages. During his time at UND, he spent two summers studying abroad in Italy under Professor Emeritus, Dr. Louis Palanca. He graduated in December of 1988 from the UND School of Law with a Juris Doctor degree. While in law school, he was a member of the North Dakota Law Review as an editorial staff member.

Professor Traynor was admitted to the Minnesota and North Dakota Bar in 1989 as well as the Federal District Courts of Minnesota and North Dakota. After a decade of working as a corporate attorney, Professor Traynor furthered his education by graduating with a Master of Insurance Laws (LLM) degree from the University of Connecticut School of Law in 2002, the first distance graduate from the UConn School of Law.

While working for State Farm Insurance Cos. in Minneapolis during the early 1990s, Professor Traynor was both a clinical and on-call attorney for the Minnesota AIDS Project (MAP) providing pro bono legal work to a population suffering from the AIDS pandemic and which, at the time, was largely ignored by government and public health officials.

Throughout his professional career, Professor Traynor has worked for the Nodak Insurance Company (Fargo, ND); State Farm Insurance Cos. (Bloomington, IL); Horace Mann Cos. (Springfield, IL); Kemper Cos. (Chicago, IL) and Coverys (Boston, MA). During that time, he was admitted to the Illinois and Michigan State Bars. The companies he worked for were involved in the property & casualty, life, health, worker's compensation and provided comprehensive insurance programs for major medical centers and teaching hospitals on the East Coast and Midwest. He has served as an expert witness in insurance litigation in several states.

Professor Traynor has published articles on insurance matters in the Connecticut Insurance Law Journal and the DePaul University of Chicago Business and Commercial Law Journal. He has recently signed a publishing contract with West Publishing to update the Third Edition of an insurance law casebook, *Insurance Law and Practice, Cases, Material and Exercises*, and is working on another article on parametric insurance bonds.

After a 29-year career in the corporate world, Professor Traynor moved back to North Dakota to be closer to his family and joined the faculty at the UND School of Law in 2019 as a Special Appointments Faculty member. He was recently granted a tenure-track faculty position by the UND School of Law. He teaches Business Associations I and II (Agency, Partnerships and Corporations), Insurance Law, Health Law and Advanced Torts.

He has four siblings, three lawyers and one surgeon, all of whom are graduates of the University of North Dakota. In his spare time Professor Traynor serves on various law school and university committees, the Grand Forks Public Schools Foundation and is a classically trained cellist who plays with the Greater Grand Forks Symphony. He lives in Grand Forks with his Beagle, Barley.

### UNIVERSITY OF NORTH DAKOTA SCHOOL OF LAW

Founded in 1899 and steeped in rich tradition, the School of Law is among the oldest degreegranting units of the University of North Dakota. It was the first of UND's professional schools to begin operations. Its first dean was Guy H. Corliss, who had served as the inaugural Chief Justice of the North Dakota Supreme Court.

Despite its meager resources, the law school grew quickly in popularity. The occupation had considerable prestige, and there was much demand for lawyers in the new state. In his history of UND, *University of the Northern Plains*, Louis Geiger observed, "perhaps no other college paid off so quickly in broadening the University's influences in North Dakota."



Since 1911, UND Law has been a member of the Association of American Law Schools. The School of Law was approved in 1923 by the American Bar Association's Section of Legal Education and Admission to the Bar and has been continuously reaccredited since.

The law school was located in downtown Grand Forks until it was moved to the UND campus during World War I. It shared a building constructed in 1922 on the corner of University Avenue and Centennial Drive with other campus departments for many years. The Law School continued to grow and ultimately took over the entire building, becoming what is known today as the School of Law. In 1973, the law school received its first major addition of a new law library, which was attached to the west side of the 1922 building.

More than 40 years later, in the 2015 fall semester, the UND School of Law took another historic step forward by completing and dedicating a \$14.4 million renovation and building addition. As a result of the project, the educational space improved significantly as additional classrooms were added, featuring a state-of-theart teaching courtroom, deliberation room and a high-tech "case study" classroom. Additional student study, collaboration and gathering space can be found throughout the addition and the renovated law library. This project has had a dramatic effect on the delivery of the education, and it has enhanced the unique spirit of community among the students.

As the state's only law school, the UND School of Law produces well-rounded legal professionals with the necessary skill set to serve as effective, innovative, and ethical leaders in North Dakota, our region, and our nation. The UND School of Law has a proud tradition of success of its graduates. A sense of pride among our alumni creates a strong alumni network that spreads across the country and around the world.
